



## **Free Cash For Crypto**

### **Our Referral Program**

**Alinea is a community first platform, so be sure to get your friends in the action. For each friend you invite to join, you'll both receive cash to invest in cryptocurrencies. You and your friend both get cash to invest in any of the 20+ cryptocurrencies if you have the correlated promotional screen in your app.**

**As soon as your friend signs up, gets approved, and invests \$20 in crypto, you'll both receive the cash gift.**

### **How to Invite Friends**

**Follow these steps to refer your friends directly from the app.**

- 1. Tap the "Free Crypto" icon in the top right corner on the Home screen**
- 2. Tap "Share my link" to invite friends**
- 3. After your friend completes the necessary steps: 1) Depositing \$20 2) Investing in crypto - you both will receive your reward**

# How to Claim Your Reward

**Follow these steps to claim your reward after your friend has shared their link with you.**

- 1. Set up your account and link your bank**
- 2. Deposit \$20**
- 3. Invest in any crypto of your choice**

## When will I receive my reward?

**Rewards will be paid out 5-7 business days after your (or your friend's) deposit clears. Returned deposits will invalidate eligibility for all promotions. Customers have 60 days to select their cryptocurrency or the reward will expire.**

## When can you withdraw cash?

**The cash value received through the Referral Program may not be withdrawn for 90 days after it is claimed. If you make a withdrawal before the 90 day period has completed, Alinea reserves the right to claim back your referral bonus.**

## Reward Limit

**You can receive up to \$50 in rewards through this program. You will stop receiving rewards after you have reached your \$50 limit.**

**However, your friends will still receive a reward if they sign up with your invite link and satisfy the conditions of the promotion.**

## **Free Cash For Cryptocurrencies Referral Offer Terms and Conditions**

**Alinea Invest, Inc. (“Alinea”) cash reward offer is subject to these Terms & Conditions.**

**Eligibility.
